

### Compass Group UK & I Better Chicken Commitment - February 2025

#### **Background**

Since signing the Better Chicken Commitment, there has been a changing landscape, which has impacted the food supply chain, ranging from Covid, the Ukraine war to the ongoing effects and consequences of Avian flu.

Despite these challenging scenarios, we recognise the significant importance of animal welfare within our supply-chain ecosystems. We continue to base our policies and approaches off the belief that all sentient beings have the right to freedom from hunger, thirst, discomfort, pain and distress and we are committed to continuously enhancing the welfare standards throughout our supply chain to reflect this.

Recognising that improving farm animal welfare standards is increasingly a collective issue for our industry, Compass Group Plc became a founding member of the Global Coalition for Animal Welfare (GCAW) in 2018. GCAW is the world's first industry-led initiative aimed at advancing animal welfare globally. Compass Group UK & I, signed up to the Better Chicken Commitment in 2019. Coupled with our commitment to achieve a 25% switch from animal protein by 2025, we can ensure that whilst we reduce our chicken consumption, the chicken we do source is of the highest welfare standards.

The below update has followed the reporting structure advice of The Humane League & Compassion in World Farming, and we have chosen to separate out our reporting metrics. 'Fresh' chicken accounts for over 80% of our total purchasing so we see value in focusing our collaborative efforts with those suppliers.

### **Progress**

Since identifying our main suppliers and working with them to understand how best to achieve the individual criteria, we have made significant progress with stocking density requirements and have opened dialogues around all other areas. We aim to release further information with regards to breed in particular, by the end of 2025. Joining the Better Chicken Business Network in January 2025 will help us to streamline strategy around all chicken products & suppliers more easily.

In addition, the BCC framework has supported our improving welfare standards across other species and Foodbuy Group UK&I will be releasing a comprehensive Animal Welfare Policy framework before summer 2025.
